We hope this mail finds you healthy, strong and continuing the struggle. Enclosed is the 2012 PARC Resource Directory, which includes suggestions and referrals for prisoners. Note that there are some new organizations listed and many addresses and phone numbers have changed, so please check out this new edition. We thank those of you who have trusted us with your letters and stories and who have returned the evaluati0on forms. Special thanks to those who pass the directory onto others to use -- according to your reports, each directory is viewed by more than 15 people. That's amazing!! This year, PARC continues to support the Justice for Oscar Grant campaign as well as the fight against the Oakland CA gang injunctions. Some PARC folks are involved with the OCCUPY OAKLAND movement and have participated in actions to shut down the west coast ports in opposition to the huge 1% corporations like Goldman Sachs, et al who control commerce across the country and in much of the world. Occupy Oakland and Occupy Los Angeles as well as other Occupy sites across the country have signed on in support of the Prisoners Hunger Strikes.

In April 2011, several prison activists groups in the bay area received mail from prisoners in Pelican Bay SHU's. These letters listed a set of concerns that grew into the 5 core demands of the strikes and there was talk of an upcoming action. On July 1, 2011, the Pelican Bay Hunger Strike was initiated by prisoners in the infamous Pelican Bay Short Corridor Security Housing Unit (the most locked down and longest locked down unit in the california dept of corrections {cdc} system). Community support was instant and strong and news of the strike became an international struggle.

cdc figures admitted that in July as many as 6600 prisoners in over 12 of the states 33 prisons were on hunger strike. On July 21, the cdc came to the table with some minimal concessions and promises to examine the 5 core demands. On August 23, the Ca Public Safety Commission held an all day hearing in Sacramento. This public hearing examined cdc practices in the SHU's: expert witnesses presented evidence of abuse and torture (as defined by Amnesty International), Exprisoners and families testified, lawyers who had recently visited some strikers submitted evidence, and new lawsuits were purposed. On September 26 due to no movement toward change by cdc, the fact that retaliation had increased, the hunger strike resumed. Over 12,000 prisoners went on strike. Within 17 days, cdc signed a contract to do more examination and reform especially in the gang validation program. Now our work/support on the outside begins in earnest to demand serious overhaul at cdc. For current information check www.prisonhungerstrikesolidarity.wordpress.com.

Please send us information that can be publicized on our website. We understand that your keepers are dangerous, therefore we will only identify your remarks by date and state.WE ARE NOT A LAW OFFICE OR A LEGAL REFERRAL SERVICE. WE CAN NOT GIVE ANY 'REAL' LEGAL ADVICE.

We do not keep a database of the prisoners we correspond with. For any further correspondence, please label the outside of your envelope "Second Contact -- No Packet Needed". We do our best to answer individual requests. Sometimes this can take a month or more based on the nature of the request and the number of volunteers we have available. We thank you for your patience. Stamps and monetary support are always needed and welcomed. To those on the outside, feel free to copy and distribute this directory. If you are in our area, call us, come visit. There is always work to do!! Stay Strong, and please stay in touch. It takes all of us united and working together to build a more humane and very different world!!

TOXIC SWEATSHOPS (this information is dated but still relavant for understanding the prison industrial complex as it continues to enslave and exploit workers for its factories) As of December 2008:

- There were 1,610,446 people held in Federal or State prisons and 785,558 people in jails, for a total of 2, 396,000 people incarcerated in the United States.
- 7.3 million men and women were under correctional supervision of some kind, including probation, parole, Federal and State prisons, and local jails. That's one in every 31 adults.
- Men make up 93% of prisoners under state or federal jurisdiction, and women make up 7%.
- About 34% of all sentenced prisoners were white, 38% were black, and 20% were Hispanic.
- The imprisonment of Blacks in the United states is 3,161 men and 149 women per 100,000 persons in the U.S. For white prisoners, the rate is 487 men and 50 women per 100,000 persons. This means Black males were imprisoned at a rate six and half times higher than white males.
- In other words, Blacks represent 12.4% of the total U.S. population, but 39.4% of the U.S. prison population, and 41% of death row.
- 127,688 prisoners are being held in private facilities.
- As of January 1, 2009 there were 3,297 death row prisoners.
- During 2009, 11 states executed 52 inmates, 15 more than the number executed during 2008. Women are the fastest growing prison population in the United States, increasing over 500% since 1970.
- Black children are nearly nine times more likely to have an incarcerated parent in prison (7%), and Latino children (2.6%) are more than three times more likely, than white children (0.8%).
- About 64% of mothers in state prisons lived with their children before prison, compared to 44% of men. What happened to those children?
- Most correctional facilities unfairly target transgender people in prison by placing them in correctional
 facilities according to their birth sex and not according to the gender they identify with: transwomen
 are incarcerated in prisons that house men and transmen are incarcerated in prisons that house
 women.

*Cells for individuals should not be used to accommodate two or more persons overnight; dormitory facilities are

Exercise and Sport

- *If not employed in outdoor work, every prisoner shall have at least one hour of exercise in the open air, weather permitting.
- *Young prisoners and others of suitable age and physique are to receive physical and recreational training.

Medical Services

- *Pre-natal and post-natal care and treatment are to be provided by women's institutions; where nursing infants are allowed to remain with their mothers, a nursery staffed by qualified persons is needed.
- *The medical officer shall see all sick prisoners daily, along with those who complain of illness or are referred to his/her attention.
- *The medical officer is to report to the director on prisoners whose health is jeopardized by continued imprisonment and on the quality of the food, hygiene, bedding, clothing, and physical regimen of the prisoners.

Discipline and Punishment

*Cruel, inhuman, and/or degrading punishments, including corporal punishment and restriction to a dark cell, shall be prohibited.

Instruments of Restraint

*Handcuffs, straitjackets, and other instruments of restraint are never to be applied as a punishment, and irons and chains are not to be used as means of restraint.

Information to and Complaints by Prisoners

- *Upon admission, prisoners shall be informed of the regulations they are to live by and of authorized channels for seeking information and making complaints.
- *Prisoners are to have the right to make complaints to the director of the institution, as well as to the central prison administration and the judicial authority, in the proper form but without censorship as to substance, and they are to have the opportunity to speak directly to an inspector of prisons outside the presence of institutional staff members.
- *Unless evidently frivolous, each complaint shall be replied to promptly.

Contacts with the Outside World

- *Prisoners are to be allowed regular contact with family and friends, by both correspondence and personal visits.
- *Prisoners who are foreign nationals shall be allowed communication with diplomatic and consular representatives of their State, or a State or international authority that has taken charge of their interests.*
- *Prisoners are to be kept informed of current events and important items of news.

Books

*Every institution shall maintain for the use of prisoners a library with recreational and instructional books.

Guiding Principles

- *The prison system must not aggravate unnecessarily the suffering inherent in a prisoner's loss of self-determination and liberty.
- *Prisons should utilize all remedial, educational, medical, and spiritual forms of assistance to treat the prisoner's needs and facilitate his return to society as a law-abiding member.
- *Government or private agencies should be available for the after care of released prisoners

Treatment

*Treatment of prisoners under sentence shall be directed to achieve the capacity for law-abiding and self-supporting lives, utilizing professional services whenever possible.

Education and Recreation

- *The ongoing education of prisoners is to be facilitated, and schooling of illiterates and youthful prisoners is to be considered compulsory.
- *Recreational and cultural activities are to be made available.
